ORDINANCE NO. 23-422

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WOODWARD, IOWA, 2006, BY AMENDING CHAPTER 69 PARKING REGULATIONS

BE IT ENACTED by the City Council of the City of Woodward, Iowa:

SECTION 1. NEW SECTIONS. The Code of Ordinances of the City of Woodward, Iowa, 2006, is amended by amending Section 69.08(13) and by adding Sections 69.08 (14-38) as follows:

69.08 NO PARKING ZONES. No one shall stop, stand or park a vehicle in any of the following specifically designated no parking zones except when necessary to avoid conflict with other traffic or in compliance with the direction of a peace officer or traffic control signal.

13. 200, 300, 400 and 500 Blocks of Locust Avenue, West side of street.
14. 200 Block of Elm Avenue, both sides of street.
15. 400 Block of Elm Avenue, East side of street.
16. 400 Block of West 3rd Street, South side of street.
17. 200 Block of Pine Avenue, East side of street.
18. 300 Block of West 4th Street, South side of street.
19. 400 Block of West 4th Street, both sides of street.
20. 500 Block of West 4th Street, South side of street.
21. 300 and 400 Blocks of West 2nd Street, South side of street.
22. 300 Block of Ash Ave, East side of street.
23. 200, 300 and 400 Blocks of West 5th Street, North side of street.
24. 200 Block of West 4th Street, North side of street.
25. 400 and 500 Blocks of Cherry Avenue, East side of street.
26. 200, 300, 400 and 500 Blocks of Maple Avenue, West side of street.
27. 200 Block of Hawk Drive, South side of street.
28. 500 Block of East 5th Street, North side of street.
29. 500 Block of East 4th Street, North side of street.
30. 500 Block of East 3rd Street, North side of street.
31. 100 Block of Oak Avenue, East side of street.
32. 200 and 300 Blocks of East 1st Street, North side of street.
33. 100, 200, 300 and 400 Blocks of Birch Avenue, West side of street.
34. 200, 300 and 400 Blocks of Cedar Avenue, West side of street.
35. 200 Block of East 3rd Street, North side of street.
36. 200 Block of East 4th Street, North side of street.
37. 200 Block of East 5th Street, North side of street.
38. Ironwood Avenue, East side of street.

SECTION 2: REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3: SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 4: WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.




